Screening/Isolation: Visual screening of all students and staff as outlined in 1e. Potentially symptomatic students will be isolated following guidance outlined in 1h. Staff will be asked to self-screen as outlined in section 1f.

Contact Tracing: Contact tracing logs will be kept for each student/cohort. Title 1 or speech pathologists entering Zion will maintain a 4 week tracking log.

Outbreak plan: Zion's outbreak protocol is outlined in section 3a.

Zion's principal will report appropriate data to [ODE's COVID-19 Weekly School Status](#) system.
